1. CALL TO ORDER/WELCOME VISITORS

Mayor Owens called the meeting to order and all stood for the Pledge of Allegiance. Mayor Owens then declared this to be an open meeting duty convened under the Open Meetings Law after receiving confirmation from the City Clerk that all legal requirements have been met.

Mayor Owens then made motion to amend the agenda for the removal of Public Hearing #2 as it was withdrawn by the Applicant. Motion was 2nd by C. Fisher and carried unanimously. Mayor Owens then made motion to remove Public Hearing #7 and postpone until January 8th. Motion was 2nd by C. Eichorst and carried unanimously. Finally, Mayor Owens made motion for the addition to #10-C for a DDA appointment. Motion was 2nd by C. Fisher and carried unanimously.

A. Comments from Community Development Director

Ms. Rimi explained that the amendments specific to the Ordinance are #2-L: Sanitary facilities, #5-D: Number of events and time frame for each, #5-H: No open flames and #5-I: Trash at location. Ms. Rimi continued that the above amendments have been recommended for approval by the Planning Commission.

B. Comments from Public

Suzanne Pengelly of McIntosh Trail asked for clarification as she is confused as she expected discussion on the Open Air Markets and the Off Street Parking which has been removed from action until January 8th.

Ms. Pengelly also referenced a discussion she previously had with C. Fisher and the removal of the Off Street Parking as it has seldom been enforced in the City.

C. Council Comment and Action

Councilman Fisher stated that he never agreed for the elimination of the Off Street Parking from the Ordinance as there are minimum standards that need to be followed and of the 26 brought to the City's attention by Ms. Pengelly, 19 are "grandfathered in" as the parking was taking place long before the Ordinance was enacted. C. Fisher added that it's possible that in the future these specific gravel lots will also have to conform. City Attorney Andrew Whalen reminded all that the Off Street Parking Public Hearing has been stricken from this evening's agenda and discussion will be appropriate when it returns January 8th. Mayor Owens made motion to approve the first read of the Amendments to Chapter 74-235 as presented & was 2nd by C. Eichorst. Motion carried unanimously.

4. PUBLIC HEARING-Ord. 17-09 Amendment to Land Development Definitions

A. Comments from Community Development Director

Ms. Rimi reviewed the amendment that in conjunction with our Stormwater Management Plan will include the call for pervious permeable parking lots which will help to soak up any run off.

Mr. Whalen stated that as a member of the MNGPD and with recent changes, an amendment is needed to our current Ordinance, specifically the section titled "Litter Control". The amendment will add that construction sites be responsible for daily debris and trash pickup.
