#### 4. ADMINISTRATIVE/FISCAL MATTERS

#### A. Mayor's State of the City

Mayor Owens read his *State of the City Address* informing residents of recent projects and activities to include updates on the General, Water & Sewer funds along with projects that are in the process throughout the City.

# **B.** General Fund Budget Amendment-Debt Service

Mr. Ferry explained that we are needing to create a line item for the 8 Police vehicles purchased last year. It has been correctly budgeted in revenues and this amendment will not affect the bottom line but it needs to be reflected in expenditures. The amount of the amendment is \$72,000 for principal and \$600 in interest. Mayor Owens made motion to approve the budget amendment as presented & was 2<sup>nd</sup> by C. Fisher. Motion carried unanimously.

# B. Establish and Name Members of the Park Committee

Mayor Owens made motion to approve Resolution No. 15-04 which establishes a Park Committee, identifying the 10 individuals who will serve. Motion was 2<sup>nd</sup> by C. Fisher and carried unanimously.

# C. Request from Southern Bicycle League to Host the Wilson 100 in the City

Victoria Seaborne asked Council to approve plans to begin the Wilson 100 on September 12<sup>th</sup> in the City beginning at 8:00. Ms. Seaborne has been made aware of concerns from last year's ride and has taken steps to correct. City Manager Richard Ferry and Chief Edens have met with Ms. Seaborne and are satisfied with the changes. Mayor Owens made motion to approve the September 12<sup>th</sup> Wilson 100 Bike Ride as presented & was 2<sup>nd</sup> by C. Grover. Motion carried unanimously. If there is an issue with using the ball fields for parking, Ms. Seaborne will present an alternative to the City.
