1. CALL TO ORDER/WELCOME VISITORS

Mayor Owens called the meeting to order and all stood for the Pledge of Allegiance. Mayor Owens then declared this to be an open meeting duly convened under the Open Meetings law after receiving confirmation from the City Clerk that all legal requirements have been met.

2. DISCUSSION AND ACTION-Site Plan for Temporary Parking submitted by Stalwart Films.

Location Manager for Stalwart Films Mike Riley asked Council for approval of a temporary parking area located on the Tencate property along Andrews Parkway. Mr. Riley continued that he has met with Code Enforcement Officer Bob Werner, reviewed the site and stated this parking area will be for crew automobiles only. Silt fence will be placed and maintained by Stalwart and the area will have security. The site will be layered with coarse sand and should have the silt fence delivered and up on Monday. Mr. Werner informed Council that he feels what has been proposed is acceptable as a temporary plan. Mayor Owens stated that the area at Tencate should have no impact to the City. C. Eichorst asked how many vehicles are expected and how long the parking is planned & was told 90 vehicles thru November 2015. Mr. Riley stated that Stalwart has a month to month contract with Tencate. C. Eichorst mentioned upcoming events in the City and the area possibly be used for event parking. Mr. Riley stated that he would be glad to work something out with the City for use however the lot will be posted "Private Property" and "No Parking" during filming. C. Grover stated that the signage will take care any liability issues. Council asked Mr. Riley before any work is done in the future that he check with City Hall for permitting and proper procedure. Mr. Riley then asked that temporary parking also be approved for Amey Street for service vehicles (catering, etc.). Crush and run will be placed at the property where an old drive already exists. C. Graham asked Mr. Werner is he sees any problems with the locations

and was told no, providing both sites are maintained. It was mentioned that the silt fence will remain until the grass begins to grow back.

Mayor Owens made motion to approve the temporary parking site on Andrews Parkway thru November 2015 & was 2nd by C. Grover. Motion carried unanimously. Mayor Owens then made motion to approve the temporary parking site on Amey Street for service vehicles & was 2nd by C. Eichorst. Motion carried unanimously.

3. ADJOURN

Mayor Owens made motion to adjourn the September 19, 2014 Called Council meeting & was 2nd by C. Grover. Motion carried unanimously.
