# A. Cemetery Contract-Cato Contracting

# **B.** Library Access Road Contract-Cato Contracting

# C. Walking Dead Filming Permit

Location Manager for the filming of Walking, Dead Mike Riley presented the plans for downtown street closings/detours and access to surrounding merchants during the May thru November filming. Mayor Belisle made motion to approve the plans with the addition of conditions discussed & was 2<sup>nd</sup> by C. Grover. Motion carried unanimously.

# D. Engineering for Park Improvement-AMEC

Mayor Belisle made motion to approve AMEC to begin the engineering on park projects to include the parking and a multi-use field at Seavy Street Park, the connection from Stonebridge Subdivision to the Seavy Street Park, the connection from Cumberland Subdivision to Cumberland Village and the Events Lawn and drainage at Marimac Park. Motion was 2<sup>nd</sup> by C. Fisher and carried unanimously.
