### FULL COUNCIL PRESENT

#### 1. CALL TO ORDER/WELCOME VISITORS

Mayor Belisle called the meeting to order, welcomed those present and asked that each of us stand for a moment of silence to remember the lives lost in Newtown, Connecticut. C. Fisher then led the Pledge of Allegiance.

Mayor Belisle declared this to be an open meeting duly convened under the Open Meetings law after receiving confirmation from the City Clerk that all legal requirements have been met.

### 2. PUBLIC HEARING-Continuation on Water & Sewer Rate Increase

#### A. Comments from City Administrator

Mr. Ferry reminded all of the reasoning behind the increase as the 2011 enterprise fund audit found that the sewer revenues were down for the first time and looking to the future, there will be fewer opportunities for builder contribution. Mr. Ferry then reviewed rate structure #4 which includes an increase in sewer rates 21% and the minimum for water will be set at \$13.75 for the first 1,000 gallon used.

# 4. ADMINISTRATIVE/FISCAL MATTERS

#### A. LMIG Bid Acceptance Contract-Piedmont Paving

Mayor Belisle made motion to award the LMIG bid contract to Piedmont Paving at a cost of 66,051.25. Motion was 2<sup>nd</sup> by C. Graham and carried unanimously.

# B. GMA Claims Settlement Request-Rowan

City Attorney Andrew Whalen explained that former employee Dan Rowan was involved in an accident in 1997, has undergone 5 surgeries and has been on disability ever since. As the fund is paying close to \$50,000 per year GMA has recommended to settle, minimizing claim exposure. GMA has obtained a MSA (Medicare Side-Aside), which is required when an injured worker is receiving social security. Medicare has approved a MSA amount of \$279,562.00. The annuitized figure is \$192,609. This is the amount of the settlement. The Fund has approved a settlement of \$150,000.00. Meaning they will reimburse us this amount. Since the MSA settlement is \$192,609.00 and the Fund will reimburse up to the \$150,000.00 GMA will pay out of pocket \$42,609.00 towards settlement of this claim. Mayor Belisle made motion to approve the Claim Settlement as presented and recommended by Attorney Whalen and GMA. Motion was 2<sup>nd</sup> by C. Graham and carried unanimously.

DDA Chair Suzanne Helfman reported that the work on the tower building is now complete and that the building has been leased with an occupy date of January 1<sup>st</sup>. The pavers are also being installed between the Welcome Center and new restaurant *Katy Lou's Café*, which is planned to open December 26<sup>th</sup>. Light Up Senoia was a great success and the Candlelight Tour of Homes was the most successful to date with 600 tickets sold. Ms. Helfman thanked all homes and SUMC that were on the tour for their participation. Ms. Helfman then presented Mr. Jack Merrick with a Certificate of Appreciation for volunteering year round at all events and activities.

Mr. Don Rehman of Heritage Point thanked Mayor Belisle for requesting a moment of silence and stated that he has three topics this evening.
