## 1. CALL TO ORDER/WELCOME VISITORS

Mayor Fisher welcomed those in attendance and all stood for the Pledge of Allegiance. Mayor Fisher then declared this to be an open meeting duty convened under the Open Meetings Law after receiving confirmation from Ms. Edens that all legal requirements have been met.

Councilman Grover made a motion to approve the August 20, 2018 City Council minutes as presented & was 2<sup>nd</sup> by Councilman Pearman. Motion carried unanimously.

# 4. ADMINISTRATIV/FISCAL MATTERS

## A. Equipment Purchase-Police Department

On behalf of the Police Department, City Manager Harold Simmons presented plans for the purchase of a new camera system that syncs the body worn and in-car cameras that will allow for split screen viewing of both camera feeds to include 12 body cameras, 12 in-car cameras and 15-months of cloud storage for \$110,276. An annual storage payment going forward will be \$14,000. Councilman Graham made motion to approve the purchase as presented & was 2<sup>nd</sup> by Councilman Grover. Motion carried unanimously.

- B. Funding-To help start City projects using monies from General Fund & repaid by SPLOST-Tabled
- C. Consider City to Deed Alley Way between Pylant Street & Andrews Pkwy back to Property Owners.

Mayor Fisher made motion to approve title searches be conducted on each property before any action is taken. Motion was 2<sup>nd</sup> by Councilman Eichorst and carried unanimously.

#### 6. NEW BUSINESS

A. Concrete Walk Way & Patio at Marimac Lake & ADA Patio at City Park
City Manager Harold Simmons stated that the City has been approached by Greg
Creighton of Legacy Church asking permission to install an ADA concrete path from the
existing driveway in front of the Stone Lodge to a landing near the water's edge. The cost
would be \$9,930.00 at approximately 1,500 sq.ft. Legacy Church would be willing to
take on the installation and fee for the project. Mr. Simmons asked if the City would be
willing to help fund the project. Councilman Grover asked if landscaping is planned
around the path and landing. Mayor Fisher suggested the city contribute

\$2,500.00 towards any landscaping needs and suggested contacting the Optimist and Rotary Clubs to see if they would help with labor. City Attorney Andrew Whalen suggested tabling the project at Marimac until DNR was contacted about buffer requirements. Mr. Simmons also stated that Mr. Creighton is proposing 2 ADA concrete patios at the Seavy Street Park at a cost of \$4,200.00. Councilman Eichorst reminded all that the Optimist club had previously donated 2-ADA picnic tables to the City and suggested funding the Seavy Street Park patios and tabling the Marimac Lake project. Councilman Pearman made a motion to approve the \$4,200 funding for the Seavy Street Park and table action on the Marimac Lake project. Motion was 2<sup>nd</sup> by Councilman Grover and carried unanimously.
