A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF SENOIA TO ACCEPT THE DEDICATION OF PUBLIC STREET DESCRIBED IN EXHIBIT A ATTACHED HERETO AND LABELED WARRANTY DEED, AND FOR OTHER PURPOSES.

as party or parties of the second part, hereinafter called Grantee (the words "Grantor" and "Grantee" to include their respective heirs, successors and assigns where the context requires or permits).

WITNESSETH that: Grantor for and in consideration of the sum of TEN AND 00/100 (\$10.00) DOLLARS in hand paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, aliened, conveyed and confirmed, and by these presents does grant, bargain, sell, alien, convey and confirm unto the said Grantee,

THIS DEED IS EXECUTED FOR THE SOLE PURPOSE OF
DEDICATING AND CONVEYING TO THE PUBLIC AND IN
PARTICULAR THE CITY OF SENOIA LOCATED IN COWETA
COUNTY, GEORGIA, FOREVER IN FEE SIMPLE, ALL
STREETS, AND RIGHTS OF WAY FOR STREETS.

SUBJECT to restrictive covenants and general utility easements of record.

TO HAVE AND TO HOLD the said tract or parcel of land, with all and singular the rights, members and appurtenances thereof, to the same being, belonging, or in anywise appertaining, to the only proper use, benefit and behoof of the said Grantee forever in FEE SIMPLE.

AND THE SAID Grantor will warrant and forever defend the right and title to the above-described property unto the said Grantee against the claims of all persons whomsoever.
