FULL COUNCIL PRESENT

1. CALL TO ORDER/WELCOME VISITORS

Mayor Fisher welcomed those in attendance and all stood for the Pledge of Allegiance. Mayor Fisher then declared this to be an open meeting duty convened under the Open Meetings Law after receiving confirmation from the City Clerk that all legal requirements have been met.

2. APPROVAL OF MARCH 19, 2018 CITY COUNCIL MEETING MINUTES

Councilman Grover made motion to approve the March 19, 2018 City Council meeting minutes as presented & was 2nd by Councilman Graham. Motion carried unanimously.

3. CLAIMS AGAINST THE CITY-None

4. ADMINISTRATIVE/FISCAL MATTERS

A. Preliminary Plat Village West

Community Development Director Dina Rimi informed Council that after review of the preliminary plat by the Planning Commission, a recommendation of approval is requested. Councilman Graham made motion to approve the Preliminary Plat for Village West as presented & was 2nd by Councilman Pearman. Motion carried unanimously.

5. UNFINISHED BUSINESS

A. 116 Baggarly Way Revisions-To Appeal Denial from Historic Preservation Commission
After instruction by Council to work with the applicant, Councilman Pearman is satisfied that the revisions to the plans presented on March 19, 2018 show a clear delineation between the original structure and the proposed addition. After requested revisions to the original plans were satisfied, Mayor Fisher made motion to overturn the denial from HPC and approve the addition for 116 Baggarly Way as presented. Motion was 2nd by Councilman Eichorst. Vote to approve was 4-1 with Councilman Graham against.

6. **NEW BUSINESS**

A. Jacob's Table - Outdoor Seating

Jules Orme is asking Council to approve outdoor seating at Jacob's Table similar to the current seating at Matt's Pizza, to include black poles with chain between. Referring to the drawing presented, Councilman Grover reminded Ms. Orme that a distance of 5 foot is required from the end of the tables to the end of the brick allowing for pedestrian traffic. Councilman Eichorst

asked about ADA compliance with access and parking and was told that there are currently 2 handicap spaces to the rear of the building and 1 up front. Councilman Grover feels the rise on the curb is currently too high and was told by City Attorney Andrew Whalen that the typical rise is 6 inches. Councilman Graham feels the current access is very narrow and asked why the ADA requirement was not originally required. Councilman Grover stated that Council approved the plans with no ramp at that end of the building and feels the City cannot put an undue burden on the applicant to construct another handicap access. Councilman Eichorst feels there should have initially been a curb cut. The general consensus of Council is that a ramp is needed at this location with Councilman Pearman adding that additional pavers may be needed as well. Councilman Grover made motion to approve the outdoor seating at Jacob's Table contingent that a 5 foot walkway for pedestrian traffic is factored in around the outdoor seating. Motion was 2nd by Councilman Pearman and carried unanimously.

Mayor Fisher made motion to approve the Master Service Agreement from VC3 at a cost of \$10.537.00. Motion was 2nd by Councilman Eichorst and carried unanimously.
