4. Administrative/Fiscal Matters

A. Appointment to Historical Preservation Commission

City Manager Harold Simmons spoke on behalf of Community Development Director Dina Rimi to appoint Mike Dobbs to the Historical Preservation Committee. Council Pearman thought he would be a good fit with Mr. Dobbs living in the historical district & his knowledge of the area. Mayor Fisher made a motion to approve and was 2nd by Councilman Pearman. 6. New Business

A. Senoia Dead Bash

Chief Edens presented an aerial view of the location of the event taking place at the Veranda Bed & Breakfast Inn on May 26, 2018. He stated that during this event a Senoia Police officer would be providing extra security but had concerns about the safety of visitors attending the event traveling across Barnes Street. He requested that the officer be able to close a section of the

road on an as needed basis. Mayor Fisher made a motion to approve and was 2nd by Councilman Graham. Motion was carried unanimously.

B. ADA Picnic Tables at Leroy Johnson Park

City Manager Harold Simmons informed the council that the city was asked to assist the Coweta County Recreation Department in purchasing ADA picnic tables for the new ballpark located on Highway 16. He requested 8 tables be purchased at \$975.00 each for a total of \$7,800.00. After several questions from the Councilmen about upkeep and installation, Mr. Simmons informed them that the county would install them and maintain the tables we were just paying the invoice. Councilman Grover made a motion to approve and it was 2nd by Councilman Graham. Motion was carried unanimously.

C. Village West/Acceptance of the roads, maintenance bonds & storm water

City Manager Harold Simmons presented and asked for approval of the roads and storm water in order for the building phase to begin. Councilman Grover shared concerns about the upkeep of the roads until the building in that area was completed. He recommended a two-year bond with renewal, making them responsible for maintaining the roads. Councilman Grover made a motion to approve with these conditions. Motion was 2nd by Councilman Pearman. Motion was carried unanimously.
