1. CALL TO ORDER/WELCOME VISITORS

Mayor Fisher welcomed those in attendance and all stood for the Pledge of Allegiance. Mayor Fisher then declared this to be an open meeting duty convened under the Open Meetings Law after receiving confirmation from the City Clerk that all legal requirements have been met.

2. APPROVAL OF MAY 21, 2018 CITY COUNCIL MEETING MINUTES

Councilman Eichorst made motion to approve the May 21, 2018 Council minutes as presented & was 2nd by Councilman Grover. Motion carried unanimously.

4. ADMINISTRATIVE/FISCAL MATTERS

A. Ordinance No. 18-02 Amendment to Chapter 6 Alcohol Beverages Section 6-21, Location Restrictions; On-Premise Consumption

City Attorney Andrew Whalen informed all that the purpose of the amendment is to allow on premises sale of package beer & wine for carry out purposes only and licenses will only be issued in conjunction with an eating establishment. Mr. Whalen stated that the amendment will become effective after the 2nd read which will occur on June 18th. Councilman Pearman made motion to approve the 1st Read of Ordinance No. 18-02 and was 2nd by Councilman Grover. Motion carried unanimously.

B. Ordinance No. 18-03 Amendment to Chapter 6 Alcohol Beverages Section 6-54, Days and Hours of Operation

Mr. Whalen stated that Ordinance No. 18-03 asks to amend the days and hours of operation, specifically the hours to sell alcohol beverages on Sundays from 11:00 AM to 12:30 AM. This ordinance requires 2 reads by Council and will also require a referendum be placed on the November 6, 2018 General Election ballot for voter approval. Ordinance No. 18-03 shall become effective November 20th only if approved by vote. Mayor Fisher made motion to approve the 1st Read of Ordinance No. 18-03 and was 2nd by Councilman Graham. Motion carried unanimously.

C. Discussion for Proposed Removal of Library Impact Fee

City Manager Harold Simmons recommends an end to the charge and collection of Library Impact Fees beginning January 2019. Mayor Fisher reminded all that the Impact Fees had previously been used for the purchase of books and has served its purpose, adding that one

seldom hears of a municipality giving back fees. Mayor Fisher then made motion to discontinue the collection of Library Impact Fees beginning January 1, 2019. Motion was 2nd by Councilman Grover and carried unanimously.
